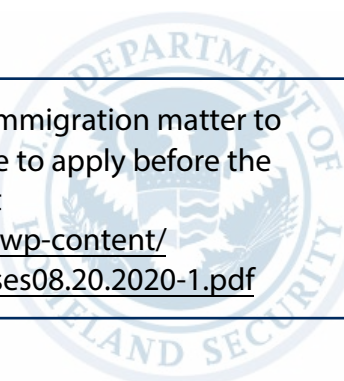

### APILO Provides Advice and Information regarding California Unemployment Insurance (UI) and Covid-19 Pandemic Unemployment Assistance (PUA)

In the past three months, over 6 million people have filed for UI. Thousands of applicants are still not receiving their benefits due to system glitches, complex and nuanced eligibility criteria and convoluted benefit calculating methods that are difficult to understand. APILO staff are currently assisting our community members with navigating the UI and PUA application processes and resolving any mistakes that have delayed receiving benefits. In the last three months, we've spoken with and assisted more than 30 clients.

### Tips on Navigating California Unemployment Benefits and Pandemic Emergency Unemployment Benefits

1. Tips to follow:
  - a. Enter your details correctly, especially social security number and date of birth.
  - b. Use the name as it appears on your social security card or driver's license.
  - c. Answer calls from EDD. They may appear as restricted or blocked.
2. Follow instructions exactly as given by EDD at: <https://www.edd.ca.gov/>
3. Call us with questions. It is better to call us with questions than to submit incorrect information.
